



**Act Agreement** made the twenty second day of

March One thousand  
nine hundred and four. **Between** Frederick William  
Washington Kingdon of Colyton in the County of Devon  
Esquire The Reverend Marmoto Queritz Clerk in Holy  
Orders formerly Vicar of Colyton and now residing at Exeter John  
Impey Scarborough of Colyford Esquire J.P. and The  
Honorable Mark George Kerr Rolfe of Bickton in the  
County of Devon (all of whom constitute the Chamber of Feoffees of  
the Parish of Colyton and are hereinafter called the Feoffees) of the  
one part and John Bull of Axminster in the County of  
Devon Cattle dealer (hereinafter called the Tenant) of the other part.

1. The Feoffees agree to let and the Tenant agrees to take the six closes  
of Pasture Land situate in the Parish of Skute in the County of Devon  
containing Twelve acres one rood and twenty seven perches (more or less)  
lately in the occupation of Samuel Wyatt and described in the Schedule  
hereto. The Tenancy to be from year to year commencing on the twenty  
fifth day of March One thousand nine hundred and four at the yearly  
Rent of Twenty pounds payable by equal half yearly payments on  
the twenty ninth day of September and the twenty fifth <sup>day of</sup> March in each year
2. All Timber and timber like Trees and all mines minerals stone and  
gravel are excepted and reserved from this demise and the Feoffees  
shall be at liberty by themselves or Agents to enter upon the said land  
with or without horses and carts at all reasonable times for the purpose  
of felling cutting digging working and carrying away the same paying  
reasonable compensation to the Tenant for any damage done thereby.
3. The Tenant shall pay the said Rent at the times and in manner  
aforesaid and shall also pay all Rates Taxes and assessments in respect  
of the said land during the Tenancy (Land Tax, Landlords property  
tax and Tithe Rent Charge only excepted)
4. The Tenant shall keep in good repair and condition all gates posts  
pales Rails and fences (but when necessary new gates shall be  
provided by the Feoffees) and shall properly scour clean and throw  
the ditches drains and watercourses and trim the hedges on the  
said Land And shall not break up or convert into tillage any  
part of the said Land nor mow the same more than once in any  
year of the Tenancy And shall not carry off any hay produced  
on the said land but shall use and consume the same with all  
dung and manure made thereon and shall stock and manage the  
same in a good and husbandlike manner and shall not assign  
underlet or part with the possession of the said Land without first  
obtaining the written consent of the Feoffees thereto but such

consent shall not be arbitrarily withheld

5. The Feoffees agree to pay the Land Tax Landlords property tax and Tithe Rent Charge and to provide new gates when necessary and that the Tenant paying the said Rent and observing the said conditions may quietly hold and enjoy the premises hereby demised without any interruption by them or any person rightfully claiming under them Lastly it is provided that if any Rent shall be in arrear for Twenty eight days (whether payment thereof shall have been legally demanded or not) or if there shall be any breach or non observance of any of the Conditions herein contained and on the Tenant's part to be observed or if the Tenant shall become Bankrupt or insolvent or make any assignment for the benefit of creditors then and in either of such cases the Feoffees may reenter the said Land and determine the Tenancy without giving any notice to quit
