To open & fill in ground from main to boundary and cover pipe with formould 6 1/2" per yard. To Tap mains & fix Ferrules 9 each. Brick up and fix Cock boxes remove all waste material, and leave the same complete 9 each. To take up pavement Curb stones and pitching, and re-laying same where supply is required 1/3 in each case. All Iron fittings such as bends & Tee pieces to be 4 each at 6/- each. Also to provide 1 inch stout Galvanized iron steam pipe at 5 1/2" per foot.
