 of the use of the Feoffee house (excepting and
 reserving to the Feoffees the Feoffee room
 store room and larder) Edward Tett
 shall to the best of his ability educate and
 instruct 25 Boys nominated by the Feoffees.
 And also supply a fair and proper quantity
 of pens paper copy-books and ciphering books
 at his sole cost. And it is hereby agreed
 that the Feoffees shall have the power of
 removing Edward Tett from the office of
 Schoolmaster at their will and pleasure
 on giving Edward Tett six months notice
 in writing; and it is hereby lastly agreed
 and Edward Tett hereby agrees to keep in
