Present:-

The Minutes of the last two Meetings were
 read and confirmed.

A letter from the Atlas Assurance Company
 was read, stating that owing to the death of their
 respected Agent, Mr. Albert Edwards, the Colyton
 Agency would be transferred to Mr. Geo. Warren,
 Land Agent, Shute; and hoping the Governors
 may see their way to continue to Mr. Warren

Late Clerk.

The Chairman, after expressing a few
 kind sentiments on the very satisfactory manner
 in which the late Clerk, Mr. Albert Edwards, had
 discharged his duties, proposed that a letter of

 seconded by Mr. Cuming, and the Governors
 signified their acquiescence by standing
 in silence.
