This Indenture made the twelveth day of October in the ninth year of the Reign of Our Sovereign Lady Anne by the grace of God of Great Britain France & Ireland Queen Defender of the faith —
Anno Domini 1710 Between William Pikes of Colyton in the County of Devon husbandman of his own part, and Francis Pratt Abraham More Church Wardens & Robert Clapp Joseph Collie and others —
Bekes Oupoks of the poor of the parish of Colyton aforesaid of the other part **Witnesseth** that the said William Pikes for and in consideration of the sume of fives pounds Lawfull money of Great Britain
to him in hand paid by the said Church Wardens and others at and before the Executed of these presents, his receipt and payment whereof he the said William Pikes doth hereby acknowledge thereof and whereas from any part
and part or thereof doth for ever acquit discharge the said said Church Wardens & others and every of them by these presents hath granted bargained sold released & assigned to the said William Pikes both grant
bargaine sell release & assign unto the said Church Wardens and Oupoks and their Successors in the said Office all that Dwelling house garden Orchard & pinnies situate lyinge being at Stamford within the said parish of
Colyton and County aforesaid now in the tenure of the said William Pikes and his wch chalfe Estate, unto the said Church Wardens & others and their Successors in the said Office together with the right Equity of Redemption of the said
pinnies and all his Estate right title interest, terms claims & demand whatsoever both at law & in Equity of him the said William Pikes unto this sume, and every or any part thereof, and all Deeds Evidence & writings
concerning the same, or relating therewerto **To have & to hold** the said Dwelling house, garden Orchard & pinnies with his appurtenances unto them the said Church Wardens & others & their Successors in an ample
benefit all manner of forms, to all intents constructions & purposes whatsoever as the said William Pikes might or could enjoy or hold the same if these & pinnies had not been made or Executed **provided**
allways and it is nevertheless agreed by the parties to these presents That If the said William Pikes his Ex: or Adm: doth and shall well & truly pay or cause to be paid unto the said Church Wardens and
Oupoks and their Successors in the said Office the full sume of fives pounds Lawfull money of Great Britain in manner of form following (to wit) Twenty Shillings on or upon the twelveth day of October in the year of
our Lord God One thousand One Thousand Seven hundred & two years according to the computation of the Church of England, and from thence forward the like sume of Twenty shillings of like lawfull money yearly and
every year on every twelveth day of October without fraud or collusion until the said sume of fives pounds shall be soe fully satisfied & paid Then these presents to be frustrate and void But if failure
shall be made of & in payment of any one or more of the said twenty shilling payments contrary to the time or times above in the said Proviso limited for payment thereof then to stand in force according to the true
meanings of these presents & of the parties thereto, any thing herein contained to the contrary notwithstanding **And** the said William Pikes for himself his Ex: or Adm: & Covenanter promiseth and agreeith to
and with the said Church Wardens and Oupoks of the poor of the parish of Colyton aforesaid and their Successors in the said Office by these presents, in manner & forme followinge (that is to say) That he the said William
Pikes his Ex: or Adm: shall and will well & truly pay or cause to be paid unto the said Church Wardens and Oupoks or their Successors the said sume of fives pounds lawfull money of Great Britain, by such
payments and at such times & times, and in such manner of forms, and to such Person or Persons as is above in the said proviso limited for his payment thereof, and shall nor will not suffer the said proviso or
condition to be broken But if the said proviso or condition shall happen to be broken that then it shall & may be lawfull for the said Church Wardens & Oupoks & their Successors (after the commencement
of quietly & peaceably to have hold, up, on, upis, possess, and enjoy to their owne proper use benefit and behoef all and singular the pinnies with their appurtenances, and every part & parcel thereof duringe
the Estate and termes herein mentioned to come and unexpired, without any his lawfull lett, suete, trouble, expulson, evictioun, molestation, hindrance or detayll of or by the said William Pikes
his Ex: or Adm: or any other Person or Persons whatsoever, and alsoe freed & discharged or otherwise well & sufficiently from time to time heretofore & indempnified by the said William
Pikes of and from all & all manner of former or other gifts, grants, leases, wills, mortgages, titles, joyntures, burthens, forfiture & incumbrances whatsoever, had, made, committed omitted or
suffered or done, or to be had, made, committed, omitted, suffered or done, by the said William Pikes his Ex: or Adm: or any other Person or Persons whatsoever One Mortgage Deed of his
said pinnies made and Executed by the said William Pikes to Thomas Simpson of Colyton aforesaid Wigmaber for the sume of £ 20 pounds of interest for the same lawfull money of Great Britain, and one other
Mortgage Deed of the pinnies aforesaid made and Executed by the said William Pikes to John Pikes of the parish of Colyton aforesaid Carpenter for the Considerations herein mentioned, which said
last mentioned Deed bears date the first day of November in the year of our Lord God One Thousand Seven hundred & two years, allways Excepted and forsprized **And** the said William Pikes doth for himself his Ex:
or Adm: Covenanter promiseth and agrees to and with the said Church Wardens & Oupoks and their Successors That he the said William Pikes his Ex: or Adm: shall and will at all times hereafter bring, first thereunto requested by the said Church
Wardens & Oupoks and their Successors, and at their roote charges in the Law, make due lvy suffer and execute, or cause and procure to be made due suffered lvy & executed all & every such further and other lawfull reasonable Act, att, lvyng
things devisor assurances & covenances in the Law whatsoever, for the further better, more perfect assurance, suretie, sure making & conveyings of the pinnies with his appurtenances & every part and parcel thereof unto them the said Church Wardens
and Oupoks or their Successors in the said Office, as by the Cowness learned in the Law of the said Church Wardens and Oupoks and their Successors shall be reasonably advised or required, soe as for the doing whereof the said
William Pikes be not compelled to travell above Twenty miles from the place of his or their abode at the time of such request soe to be made **In Witness** whereof the parties aforesaid have to these presents interchangably their
