successors and assigns or any person lawfully or equitably claiming any estate right title or interest in or to the said hereditaments
so purchased by the Feoffes as aforesaid or any part thereof at the cost of the person or persons requiring the same produce and shew
to him them or any of them or to such person or persons as he or they shall require or at any trial hearing or next
examination in any Court of law or other Judicature or in the execution of any commission or elsewhere in England as and
occasion shall require the said Deed specified in the said Schedule hereto for the manifestation defence and support of the estate
title and possession of the Feoffes their successors and assigns and every or any such other persons as aforesaid And will at
