of the other p^{tes} the said Hoofood by & wth the consent & assent of the worthy men of y^e parish of Colyton aforesaid as well
for consideration of the sum of five pound's of lawfull money of England to the said Hoofood in hand well & truly paid att & before them sealing & delivery hereof by y^e
said Thomas Redwood the receipt whereof is hereby acknowledged as also in consideration of y^e yearly rent & services on the p^{tes} & behalfs of y^e Thomas Redwood
hereafter in these presents mentioned & reserved to be paid & performed to the said Hoofood their heirs or assigns **HAVE** demised lease granted to Farm Lott
by these presents do demise grant to Farm Lott unto the said Thomas Redwood all that messuages or dwelling house in y^e town of Colyton
being then divided into two tenements but now or lately in the usurpation of one John Lovridger & the garden & close or y^e roll of land thereunto adjoining containing
by estimation half an acre or more or less situate lying & being in Colyton aforesaid is bounded on y^e east & south wth y^e Queens highway to goate wth all ways paths & commons
profits commodities & advantages w^{ch} soever to y^e said messuage garden close or y^e roll of land belonging or in any wise appertaining except & always reserved out of this
tenement demise grant unto y^e Hoofood their heirs or assigns all y^e trees now standing growing or being or w^{ch} shall stand grow or be in & upon y^e premises or any p^{tes}
thereof w^{ch} hee shal liberty to view fall cut down & carry away y^e same at their will & pleasure **TO HAVE AND TO HOLD** the messuages & dwelling house garden & close or
y^e roll of land & y^e p^{tes} & y^e roll thereof with the appurtenances (except before excepted) unto y^e Thomas Redwood his Exor. Adm^r & Assignes from hence forth for ever during
y^e full time & term of years & years from thence next ensuing & fully to be computed expired & ended w^{ch} the said Thomas Redwood Elizabeth his wife Mary Drake daughter of Thomas Drake
or any or either of them shall so long happen to live **YELLDURGE** & paying thereof yearly & every year for the first two years of y^e term hereby granted unto y^e Hoofood
their heirs or assigns y^e sum or yearly rent of four pound's & four shillings of lawfull money of England **AND** also yielding & paying thereof yearly & every year after y^e
expiration of y^e first two years during y^e term hereby granted unto y^e Hoofood their heirs or assigns y^e sum & yearly rent of four shillings of like lawfull money of England
all y^e four most usual feasts or terms in y^e year (that is to say) at y^e feast of St. John Baptist St. Michael all the churching of the birth of our Lord God & the Annunciation of the
Blessed Virgin Mary by even & equal portions **AND** also yielding paying & performing & acquitting y^e high & low rents rates & duties Burrough w^{ch} & tithes & services
of y^e same demised premises what so ever during y^e term **AND** the said Thomas Redwood doth for himself his Exor. Adm^r & Assignes & assigns & assigns & assigns & assigns
their heirs & assigns that the y^e Thomas Redwood his Exor. Adm^r & Assignes shall & will well & sufficiently repair & sustaine & uphold & amond y^e demised premises & every part
& p^{tes} thereof ad well in housing walling by masonry & covering ad also in hedges ditches & gates & all oth necessary reparations what so ever **BUT** if it shall happen y^e y^e yearly rent of
four pound's & four shillings or y^e said yearly rent of four shillings be behind or unpaid in p^{tes} or in all by y^e space of eight & twenty days next after any or either of the said feasts or
days of paym^{ts} in w^{ch} aforesaid y^e same ought to be paid being lawfully demanded & no sufficient distress in & upon y^e premises can or may be found for y^e levying of y^e rent with
the charges if any happen to be **OR** if y^e Thomas Redwood his Exor. Adm^r or Assignes shall at any tyme or by mes hereafter suffer y^e messuages or any p^{tes} thereof to be run down
or in decay to y^e value of ten shillings or above & do not well & sufficiently repair & amond y^e same w^{ch} in one month next after notice thereof given by y^e said Hoofood or their
Bayliff or Bayliff's **THAT** then & all tyme after for y^e p^{tes} & parts of y^e messuages or parts of the premises this present demise & lease shall be void & frustrate & the term
hereby limited shall immediately determine & be utterly void & that it shall & may be lawfull to & for y^e Hoofood their heirs or assigns Bayliff & Bayliff's into y^e said demised
premises to reenter & the same & every p^{tes} & y^e roll thereof to have againe & possess & enjoy ad in his & their former state These presents Indentures or any thing in them contained to
the contrary in any wise notwithstanding **In** witness whereof the parties abovesaid have to these presents Indentures intortunately their hands & seals set & given
the day & year first abovesaid.
